RESOLUTION NO. 24-26

BAC RESOLUTION RECOMMENDING AWARD OF THE CONTRACT FOR THE CONSTRUCTION OF MULTI-PURPOSE BUILDING (COMPLETION) LOCATED AT CAMILMIL, CALAPAN CITY THROUGH NEGOTIATED PROCUREMENT OF ADJACENT OR CONTIGUOUS CONTRACT

WHEREAS, the project "Construction of Multi-Purpose Building in the City of Calapan" located at Camilmil, Calapan City" with an approved budget for the contract of 4,987,273.34 was procured through competitive bidding held last January 03, 2024.

WHEREAS, the said project was awarded to Blue Precision Engineering, Construction and Supply in the contract amount of Four Million Nine Hundred Eighty-Three Thousand, One Hundred Forty-Seven and Three Centavos (PhP4,983,147.03) which was approved by the Head of the Procuring Entity through Bac resolution No. 24-02-A;

WHEREAS, the project is on-going and in its final stages and City Government of Calapan deemed it necessary and proposed additional works essential to the useability and functionality of the abovementioned Multi-Purpose Building;

WHEREAS, Section 53 of the 2016 Revised IRR of RA 9184 allows Negotiated Procurement where the subject contract is adjacent or contiguous to an ongoing Infrastructure Project or Consulting Service;

WHEREAS, the contract for the additional works to be done on the abovementioned Multi-Purpose Building conforms to the conditions provided under Section 53.4 of the 2016 Revised IRR of RA 9184 which states:

"Where the subject contract is adjacent or contiguous to an ongoing infrastructure Project where the contractor have expertise to deliver the required service: Provided, however, That (a) the original contract is the result of a competitive Bidding; (b) the subject contract to be negotiated has similar or related scopes of work; (c) it is within the contracting capacity of the contractor; (d) the contract uses the same prices or lower unit prices as in the original contract less mobilization cost; (e) the amount of the contiguous or adjacent work involved does not exceed the amount of the ongoing project; and (f) the contractor has no negative slippage/delay. Provided, further, That negotiations for the procurement of the contiguous or adjacent work are commenced before the expiry of the original contract".

WHEREAS, with the abovementioned conditions having been met, the Bids and Awards Committee, as it resolved in BAC resolution No. 24-24C, proceeded to directly negotiate with Blue Precision Engineering, Construction and Supply, the contractor of the "Construction of Multi-Purpose Building in the City of Calapan" project;

WHEREAS, in the negotiation held on August 29, 2024 at the Bac Office, 2nd Floor Executive Bldg., New City Hall, Guinobatan, Calapan City, between the Bids and Awards Committee and Mr. Loues Emmanuel R. Ladimo, authorized representative of Blue Precision Engineering, Construction and Supply, the parties agreed on stipulations contained in a subsequent negotiation agreement for the contractor to undertake the completion project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to recommend the award of the contract for the project

RESOLVED, this 4th day of September, 2024 at the Bids & Awards Committee Conference Room, New City Hall, Calapan City.
