RESOLUTION NO. 24-24C

BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT - ADJACENT OR CONTIGUOUS FOR THE CONSTRUCTION OF MULTI-PURPOSE BUILDING (COMPLETION) LOCATED AT CAMILMIL, CALAPAN CITY

WHEREAS, the City Government of Calapan through its Bids and Awards Committee conducted the competitive bidding for the project "Construction of Multi-Purpose Building in the City of Calapan located at Camilmil, Calapan City" on January 3, 2024 and recommended the award of contract to Blue Precision as the bidder with the Lowest Calculated and Responsive Bid which was approved by the Head of the Procuring Entity;

WHEREAS, the contract implementation started on March 14, 2024 and will end on September 13, 2024 ;

WHEREAS, on August 16, 2024 , the City Government of Calapan requested for the construction of the completion through section 53.4 (Adjacent or Contiguous) of the 2016 Revised IRR of RA 9184 in view of the following : 1. Painting Works (Masonry Painting), 2. Painting Works (Wood Painting), 3. Aluminum Glass Window, 4. Aluminum Glass Door, 5. Steel Works (Fire Exit) and 6. PWD Ramp;

WHEREAS, Section 53 of the 2016 Revised IRR of RA 9184 states that Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, the request met all the conditions under Section 53.4, to wit:

"Where the subject contract is adjacent or contiguous to an ongoing infrastructure Project where the contractor have expertise to deliver the required service: Provided, however, That (a) the original contract is the result of a competitive Bidding; (b) the subject contract to be negotiated has similar or related scopes of work; © it is within the contracting capacity of the contractor; (d) the contract uses the same prices or lower unit prices as in the original contract less mobilization cost; € the amount of the contiguous or adjacent work involved does not exceed the amount of the ongoing project; and (f) the contractor has no negative slippage / delay. Provided, further, That negotiations for the procurement of the contiguous or adjacent work are commenced before the expiry of the original contract".

WHEREAS, use of this alternative method of procurement in negotiating with the contractor of the ongoing project will be more economical and efficient;

WHEREAS, the project will be completed within forty nine (49) calendar days starting from the receipt of the Notice to Proceed.


