**NOW THEREFORE**, We, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is **RESOLVED**;






To recommend for the approval of the City Mayor, **MARILOU F. MORILLO** of the City Government of Calapan of the foregoing findings.


