
To recommend for the approval of the City Mayor, **MARILOU F. MORILLO** of the City Government of Calapan of the foregoing findings;

**RESOLVED**, this 28<sup>th</sup> day of January 2025 at the Bids & Awards Committee Conference Room, New City Hall, Calapan City.


